**ORDER**

Whereas for preventing danger, obstruction or inconvenience to the public in connection with observance of **Sahid Diwas** by West Bengal Pradesh Trinamool Yuba Congress Committee in front of Head Office of CESC Ltd. i.e. Victoria House, Kolkata on **21.07.2024**, it is necessary in the interest of Public safety, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate area. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue following restriction order as per following time schedule on the following roads --

**Date & Time –**

On 21.07.2024 from 02:00 hrs. to 20:00 hrs.

**Restrictions for all type of Goods Vehicles (except emergency vehicles, LPG vehicles, Vegetable, Fruits & Milk carrying vehicles)**

1. Nimtala crossing towards Bally along GT Road.
2. Ballykhal Island towards Bally along GT Road.
3. Bamundanga Island towards Bally & Dakshineswar along GT Road & Vivekananda Setu.
4. NH-2 & NH-6 crossing towards Nibedita Toll.
5. Near Salap More towards Dasnagar along Howrah Amta Road on Kabardanga Morh.
6. Kona Morh on NH-6 towards Liluah along Benaras Road towards Jagadishpur.
7. Kazipara crossing towards Kolkata & towards Howrah via 2nd Hooghly Bridge and GT Road.
8. Near Alampur Morh towards 2nd Hooghly Bridge along Andul Road.
9. Hung Sung crossing towards Drainage Canal Road and 2nd Hooghly Bridge.
10. Kona Truck Terminal towards Kolkata & Howrah City side along Kona Express way and 2<sup>nd</sup> Hooghly Bridge.
11. Near Nibra Morh to towards Kolkata & Howrah City along Kona Express way and 2<sup>nd</sup> Hooghly Bridge.
12. Howrah & GT Road bound via 2<sup>nd</sup> Hooghly Bridge & Kona Express way.

In addition to the above, no Goods Vehicles will be allowed to ply within this Commissionerate area from 02:00 hrs to 20:00 hrs. on 21.07.2024.

**Restrictions for all other vehicles:**

All Panchantala bound passenger vehicles will be diverted from Sarat Statue at GR Road towards Fish Market via IC Bose Road, CM Bridge, GT Road, Phansitala, Panchantala at Howrah.

No vehicle will ply along M.G. Road, Church Road, Nityadhan Mukherjee Road.

**Restrictions of slow moving vehicles:**

Slow moving vehicles will be restricted to ply along Foreshore Road, G.T. Road, Panchantala Road, N.S. Road, Grand Foreshore Road, Girish Ghosh Road, Aravindo Road, J.N. Mukherjee Road, Andul Road, Drainage Cannel Road, East West Bye Pass Road from 9 AM to 12 PM on 21.07.2024.

**These regulations will remain in force in addition to the other normal traffic restrictions on the day (21.07.2024), which are not repugnant to the above.**
