WHEREAS, the **National Testing Agency** will conduct the **UGC-NET, JUNE-2024 Examination (1<sup>st</sup> Phase)** on **21.08.2024, 22.08.24 and 23.08.24** in two shifts, (1<sup>st</sup> shift from 09.00 hrs to 12.00 hrs and 2<sup>nd</sup> shift from 15.00 hrs to 18.00 hrs) on each day at the following examination centre under Howrah Metropolitan area as communicated vide Memo No. 76 (14)/ADG (HQ) dated 16.08.2024 of Additional Director General (HQ), West Bengal and Memo No. 131(14)/CR Dated 17.08.2024 of Additional Director General & Inspector General of Police (Law and Order), West Bengal.

WHEREAS, there is every apprehension of breach of peace and tranquility on the day of examination in the vicinity of examination centre,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centre,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974) presently Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of the above mentioned examination centre within the Metropolitan area of Howrah **from 06:00 hrs to 19.00 hrs on the days of UGC-NET, JUNE-2024 Examination as noted above.**

And all the **Cyber Café/Photo Copy/Printing Shops** operating within **200 to 300 meters** from the above examination centre shall not be allowed to operate from **06:00 hrs. to 19.00 hrs.** during the hours of examination mentioned above on the aforesaid days.

And any loud speaker **within 100 (hundred) meters** shall not be allowed to play from **06:00 hrs. to 19.00 hrs.** during the hours of examination mentioned above on the aforesaid days.
