WHEREAS, there is every apprehension of breach of peace and tranquility on those days of examination in the vicinity of examination centres,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid days in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. - 1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023), do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of all the examination centres within the Metropolitan area of Howrah from 06:30 hrs. to 14:30 hrs. on each day of the Secondary School Examination-2025 (Class-X) and Senior School Certificate Examination-2025 (Class-XII) as mentioned above.

And all the **Photo Cyber Café/Photo Copy/Printing Shops** operating within 100 (hundred) meters from all the examination centres (list enclosed) shall not be allowed to operate from **06:30 hrs. to 14:30 hrs.** during the hours of examination mentioned above on the aforesaid days of the **Secondary School Examination-2025** (Class-X) and Senior School Certificate Examination-2025 (Class-XII).

There will be complete prohibition of use of loud speakers/ public address systems from three days before to the commencement of the **Secondary School Examination-2025 (Class-X) and Senior School Certificate Examination-2025 (Class-XII)** and prohibition will remain in force till completion of the examinations.
