ORDER

Whereas it is necessary in the interest of public safety and convenience for restriction and diversion of goods vehicles in connection with ongoing construction work for the six-lane elevated corridor on Kona Expressway. Movement of all types of Goods Vehicles shall be restricted / regulated through Kona Express way on NH-117 both flanks **from 10.08.2025 to till completion of construction of six lane elevated corridor**. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders on the following roads -

➤ **Restrictions / Diversion Point:**

1. No Kolkata bound Goods Vehicles shall be allowed to avail Kona Expressway from Nibra between 06:00 hrs to 23:00 hrs.
2. No Howrah bound Goods Vehicles shall be allowed to avail Kona Expressway through 2nd Hooghly Bridge between 06:00 hrs to 23:00 hrs.
3. All Howrah bound Goods Vehicles coming from Kolkata side intending to avail NH-16/NH-19 via Kona Expressway will be allowed to avail either 2nd Hooghly Bridge Toll Plaza-Kona Expressway-Nibra-NH16 or 2nd Hooghly Bridge Toll Plaza-Howrah Andul Road-Alampur-NH-16 between 23:00 hrs to 06:00 hrs only. The height of Goods Vehicles coming from Kolkata and going towards Mourigram ROB via Andul Road should be less than 4.5 meters.
4. All such Goods Vehicles coming from Kolkata side intending to avail NH-19 through Nivedita Setu will be allowed to avail Tala Bridge-Nibedita Setu- Maitypara- towards Dankuni crossing between 22:00 hrs to 06:00 hrs only.
5. All Goods Vehicles going to Kolkata coming from Dankuni side shall be allowed to avail Dankuni crossing-Maitypara-Nibedita Setu-Tala Bridge between 22:00 hrs to 06:00 hrs.
6. All Goods Vehicles going to Kolkata coming from Kolaghat side availing NH-16 shall be allowed to avail Ranihati-Dhulagarh-Nibra-Kona Expressway-Vidyasagar Setu between 23:00 hrs to 06:00 hrs or Ranihati-Dhulagarh- Nibra-Pakuria-CCR Bridge-Nibedita Setu-Tala Bridge between 22:00 hrs to 06:00 hrs for entering into Kolkata.
7. No Kolkata bound Goods Vehicle shall be allowed to enter from Alampur towards 2nd Hooghly Bridge Toll via Andul Road throughout the day for full 24 hrs.
8. No Kolkata bound Goods Vehicle shall be allowed to enter from Salap / TC Motors towards 2nd Hooghly Bridge Toll via Howrah-Amta Road for full 24 hrs.
9. No Kolkata bound Goods Vehicle shall be allowed to enter from Kona More towards 2nd Hooghly Bridge Toll via Benaras Road for full 24 hrs.
10. No Kolkata bound Goods Vehicle shall be allowed to enter from Shanpur More towards 2nd Hooghly Bridge Toll via Kona Expressway for full 24 hrs.

11. No Kolkata bound Goods Vehicle entering from Ankurhati Prasastha Road / Saraswati Bridge Underpass or any other internal road shall be allowed to move towards Kona Expressway or Howrah-Andul Road to avail 2nd Hooghly Bridge for full 24 hrs.
12. No Goods Vehicles will be allowed to avail G.T. Road towards Kolkata through 2nd Hooghly Bridge or towards Nibra / NH-16 through Kona Expressway between 06:00 hrs to 23:00 hrs.
13. No Goods Vehicles will be allowed from Kazipara towards Kolkata through 2nd Hooghly Bridge or towards Nibra / NH-16 through Kona Expressway between 06:00 hrs to 23:00 hrs.
14. No Goods Vehicles will be allowed from Shalimar towards Kolkata or Nibra / NH-16 between 06:00 hrs to 23:00 hrs.
15. Point of destination(s) should be clearly displayed on windscreens of the Goods Vehicles so as to enable the Police Authorities to identify the vehicles and guide them properly to their destination point(s).

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.

THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS WHICH ARE NOT REPUGNANT TO THE ABOVE.
