5. Near Nibra More towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
6. Ramp of 2nd Hooghly Bridge towards Mandirtala.
7. T.C. Motor near Salap More towards Kolkata via 2nd Hooghly Bridge.
8. NH2 & NH6 crossing towards Nibedita Setu.
9. 'O' point towards Old Bally Bridge / Nibedita Setu.
10. Nimtala X-ing towards Bally along GT Road.
11. Ballykhal Island towards Bally along GT Road.
12. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally

Movement of Other Vehicles:
