Whereas for peaceful observance in connection with the "Rath-Yatra" festival to be celebrated on 07.07.2024 and Punar-Yatra (Ultra-Rath) on 15.07.2024 & 16.07.2024 throughout the Howrah Police Commissionerate area, it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the Procession, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate during the period. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, I, Praveen Kumar Tripathi, *IPS*, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules on the following roads-

Restrictions for All types of Goods Vehicles:

Movement of all types of Goods Vehicles (Except vehicles carrying LPG Cylinders only, Petroleum, Oil, Lubricants & Oxygen, Vegetable, Medicine, Fruits, Fish & Milk carrying vehicles) will be restricted from 13:00 hrs to 22:00 hrs on 07.07.2024 and from 13:00 hrs to 22:00 hrs on 15.07.2024 & 16.07.2024 on the following roads:

- 1. No Goods vehicles will be allowed to move towards Ranihati along NH-16 from Kona morh.
- 2. No Goods vehicles coming from Kolkata side will be allowed to move towards Ranihati crossing along NH-16 from Nibra.
- 3. No Goods vehicles will be allowed to move towards Ranihati crossing along NH-16 from Alampur crossing.
- 4. No Goods vehicles will be allowed to move towards Ranihati crossing along NH-16 from Dhulagarh crossing.
- 5. No Goods vehicles should be allowed to move towards Ranihati crossing along NH-16 from Panchla side.
- 6. No Goods vehicles should be allowed to move towards Ranihati crossing from Maitypara along NH-16.
- 7. No Goods vehicles should be allowed to move towards Ranihati crossing along NH-16 from Nivedita Toll or Bally side.
- 8. No Goods Vehicles should be allowed to move in Howrah City area.
- THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THOSE DAYS, WHICH ARE NOT REPUGNANT TO THE ABOVE.

WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur Police Station) in the town of Howrah (hereinafter referred to as the said areas). WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974) presently Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023).

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the **9th July, 2024 to 06th September, 2024** until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

3)	On the West by	-	K. M. Banerjee Road, Circular 2 nd Bye Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road upto old 58 Bus stand.
4)	On the South by	-	Tarapada Chatterjee Road, Upen Chatterjee Road upto Betaitala More.

5) Explanation - In this order, the Town of Howrah means the town of Howrah as defined in Section 2(15) and Schedule - I of the Howrah Municipal Corporation Act, 1980 (Act of 29 of 1980).
