Whereas for preventing danger, obstruction or inconvenience to the public in connection with NABANNA ABHIYAN being organized by Paschim Banga Chatra Samaj on 27.08.2024, it is necessary in the interest of Public safety, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate area. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue following restriction order as per following time schedule on the following roads --

Restrictions / Diversion for All types of Goods Vehicles (except emergency vehicles, LPG vehicles, Vegetable, Fruits & Milk carrying vehicles)

Movement of all types of Goods Vehicles & Auto / TOTO will be restricted on 27.08.2024 from 04:00 hrs to 20:00 hrs. on the following roads:

- All kinds of Goods vehicles will be restricted at No entry point at Alampur under flyover towards Andul Road 2nd Hooghly Bridge.
- 2. At Nibra-1 & 2 point from NH-16 towards Kona Express way.
- 3. Ramp of 2nd Hooghly Bridge towards Mandirtala.
- Kona Truck Terminal towards Kolkata & Howrah City side along Kona Express way and 2nd Hooghly Bridge.
- T.C. Motor near Salap More towards Kolkata via 2nd Hooghly Bridge.
- 6. Salap Bazar towards Bankra/Dasnagar.
- 7. Howrah & GT Road bound via 2nd Hooghly Bridge & Kona Express way.
- 8. Coal depot towards Howrah along Foreshore Road.
- Howrah Railway Museum towards Banstala Ghat Crossing on Grand Fore Shore Road.
- 10. Shalimar towards Andul Road and Kona Expressway & 2nd Hooghly Bridge Howrah jurisdiction.
- 11. Maitypara Crossing towards NH-16 / Bally.
- 12. NH-2 & NH-16 Crossing towards Nibedita Setu.
- 13. O point towards Old Bally Bridge / Nibedita Setu.

- 17. Kalitala Crossing towards Naskarpara (if necessary).
- Bandhaghat Crossing towards Aurobindra Dutta Road (if necessary).
- 19. Panchantala bound Vehicles will be diverted towards Hari Mohan Dey Rd C M Bridge Fanshitala- Belilious Rd- East West Bye Pass both way (if necessary).
- 20. Howrah Maidan bound buses will be diverted from New Cab Road U turn from New Cab Road cut out (if necessary).
- 21. All Vehicles will be diverted from R.B. Setu towards 27A point or Harimohan Bose Road.

These regulations will remain in force in addition to the other normal traffic restrictions on the day (27.08.2024), which are not repugnant to the above.
