WHEREAS, there is every apprehension of breach of peace and tranquility on the day of examination in the vicinity of examination centres,

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of the above mentioned examination centres within the Metropolitan area of Howrah **from 06:30 hrs. to 15:30 hrs. on the day of National Means cum Merit Scholarship Examination (NMMSE) 2024, as mentioned above.**

And all the Photo Cyber Café/Photo Copy/Printing Shops operating within 100 meters from the above examination centres shall not be allowed to operate **from 06:30 hrs. to 15:30 hrs.** during the examination mentioned above on the aforesaid day.

And any loud speaker within 100 (hundred) meters shall not be allowed to play **from 06:30 hrs. to 15:30 hrs.** during the examination mentioned above on the aforesaid day.

Whereas it is necessary for preventing danger, obstruction or inconvenience to the public in connection with the TATA Steel Kolkata Marathon on 15.12.2024, it is informed by Kolkata Police vide No. TP / 55 dated 12.12.2024 of Commissioner of Police, Kolkata that movement of all types of Goods Vehicles (except Emergency Goods Vehicles) shall be restricted in the city of Kolkata within Kolkata Police jurisdiction through Vidyasagar Setu **from 04:00 hrs to 13:00 hrs or till completion of the Marathon on 15.12.2024.** In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules on the roads.

Restrictions for Goods Vehicles:

Movement of all types of Goods Vehicles (except emergency Goods Vehicles) shall be prohibited to ply along various roads towards Kolkata City through Vidyasagar Setu from 04:00 hrs to 13:00 hrs or till completion of the Marathon on 15.12.2024.

1. All types of goods vehicles will be restricted 'No Entry' point at Alampur towards Andul Road / 2nd Hooghly Bridge.
2. All types of goods vehicles restricted from Kazipara Crossing towards Kolkata via 2nd Hooghly Bridge.
3. All types of goods vehicles restricted from Hung-Sung Crossing towards 2nd Hooghly Bridge.
4. All types of goods vehicles will be restricted at Kona Truck terminal towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
5. All types of goods vehicles restricted from Nibra More towards Kolkata & Howrah City along Kona Expressway & 2nd Hooghly Bridge.
6. All types of goods vehicles restricted from Mondirtala towards Kolkata via 2nd Hooghly Bridge.
7. All types of goods vehicles restricted from Bataitala Ramp towards Kolkata via 2nd Hooghly Bridge.
8. All types of goods vehicles restricted from T.C. Motor near Salap More towards Kolkata via 2nd Hooghly Bridge.

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.

The above regulation shall be enforced in addition to the normal restrictions which are not repugnant to the above.
