WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid days in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023), do hereby

prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of all the examination centres (list attached herewith) within the Metropolitan area of Howrah from **06:30 hrs. to 15:00 hrs.** on each day of the aforesaid examination.

And all the **Photo Cyber Café/Photo Copy/Printing Shops** operating within 100 (hundred) meters from all the examination centres (list enclosed) shall not be allowed to operate from **06:30 hrs. to 15:00 hrs.** during the hours of examination mentioned above on the aforesaid days.

There will be complete prohibition of use of loud speakers/ public address systems from three days before to the commencement of the Madhyamik Pariksha (Secondary Examination), 2025 and prohibition will remain in force till completion of the examinations.

8. NH-19 & NH-16 crossing towards Nibedita Setu.
9. 'O' point towards Old Bally Bridge / Nibedita Setu.
10. Nimtala crossing towards Bally along G.T. Road.
11. Ballykhal Island towards Bally along G.T. Road.
12. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally.

Exceptions –

Whereas for peaceful observance of **SNAN-YATRA of SITALA MATA** festival to be celebrated on **11.02.2025** it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the YATRA, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate during the period. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules on the following roads.

Restrictions for Goods Vehicles:

Movement of goods vehicles will be restricted from 02:30 hrs on 11.02.2025 to 12:00 hrs on 12.02.2025 on the following roads:

1. From Bamundanga Island on NH-19 up to Nimtala crossing.
2. From Nimtala crossing towards Bally along GT Road.
3. From Ballykhal Island towards Bally along GT Road
4. From Goshala Road towards Matawala Chowrasta through Liluah fly over.
5. From Kona crossing on Benaras Road towards Bamungachi Bridge.
6. From Chatterjeepara Crossing on Natabar Pal Road up to Belgachia crossing on Benaras Road.
7. Bamungachi Bridge on Benaras Road.
8. 'A' Road & Jhil Road under Liluah PS.

Restriction for All types of vehicles:

The movement of all types of vehicular traffic (except for vehicles being used by students/examinees of all schools and colleges / any vehicle used for the purpose of School / College examination) will be remain suspended on the following roads from 11:00 hrs. on 11.02.2025 till completion of SNAN-YATRA.

- 13) From Salkia School Road & Upendra Mitra Lane crossing towards G.T. Road via Jeliapara Lane and vice-versa.

There will be complete prohibition of use of loud speakers/ public address systems from three days before to the commencement of the **Secondary School Examination-2025 (Class-X) and Senior School Certificate Examination-2025 (Class-XII)** and prohibition will remain in force till completion of the examinations.
