Please refer to the Police Order No. 06 of 2005, Police Order No. 09 of 2010, Police Order No. 07 of 2011 and Police Order No. 05 of 2014. It is mentioned in the said orders that, (i) there will be a Protection of Women and Children Cell in the Headquarter of every District/ Commissionerate of West Bengal Police headed by one Inspector with at least two Sub-Inspectors of which at least one will be a lady, two ASIs and two Constables. The POWC cell will act as Nodal agency for Crime Against Women and Children in the District/ Commissionerate.

The POWC Cell will work as the Special Juvenile Police Unit under Juvenile Justice (Care and Protection of Children) Act, 2000 and Juvenile Justice Rules 2007 and will coordinate with West Bengal Women Commission, All State and National Commissions and all other concerned agencies. POWC Cell will also act as Anti Human Trafficking Unit of District/ Commissionerate and will function as described in the MHA Advisory (F/No. 15011/06/2009-ATC dated 09.09.2009 & 10.09.2010 on Preventing and Combating Human Trafficking in India). The AHTU will mandatorily take over the investigation of cases of children who are missing for more than Four months (As per the order of Hon'ble Supreme Court Bachpan Bachao Andolan- vs- Union of India in WP(C) No. 75/2012).

(ii) In conformity with the Police Orders as mentioned above, an officer in the rank of Dy.SP will be the Nodal Officer to supervise all these sections. The Inspector of Missing Persons Bureau of the District/ Commissionerate will be the ex-officio Inspector of SJPU and Inspector of AHTU and will head the POWC Cell. One officer in the rank of Sub-Inspector shall be designated as the Nodal Officer in the Police Station level and one officer in ot below the rank of ASI will be the Juvenile and Child Welfare Officer in every Police Station in terms of Section 63 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (as mentioned in Police Order No. 06 of 2005)

In conformity with the above orders and in suppression of the earlier order issued from this office vide C.O. No. 3010 dated 01.12.2022, It is hereby ordered that,

- a) DCP HQ, HPC will supervise the functions of POWC Cell/SJPU/AHTU on regular basis.
- b) ACP EB, HPC will be the Nodal Officer to supervise POWC Cell, SJPU, MPB and AHTU.
- c) Inspector-in-Charge, Women PS with additional charge of Inspector MPB will be the ex-officio Inspector of SJPU and AHTU and will head the POWC Cell in Howrah Police Commissionerate.
- d) Second Officers in the rank of Sub-Inspector of all Police Stations will be designated as the nodal officer at the PS level.

WHEREAS, there is every apprehension of breach of peace and tranquility on those days of examination in the vicinity of examination centres,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid days in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023), do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of all the examination centres (list attached herewith) within the Metropolitan area of Howrah from **06:00 hrs. to 14:30 hrs.** on each day of the Higher Secondary Examination.

And all the Photo Cyber Café/Photo Copy/Printing Shops DASNAGAR PS: operating within 100 (hundred) meters from all the examination centres (list enclosed) shall not be allowed to operate from 06:00 hrs. to 14:30 hrs. during the hours of examination mentioned above on the aforesaid days.

There will be complete prohibition of use of loud speakers/ public address systems from three days before to the commencement of the Higher Secondary Examination, 2025 and prohibition will remain in force till **DOMJUR PS:** completion of the examinations.

Whereas for preventing danger, obstruction or inconvenience to the public in c/w the Higher Secondary Examination, 2025 will be held on 03.03.2025, 04.03.2025, 05.03.2025, 06.03.2025, 07.03.2025, 08.03.2025, 10.03.2025, 11.03.2025, 13.03.2025, 17.03.2025 and 18.03.2025.It is vide Notifications informed bv Kolkata Police Traffic No TP/11dated28.02.2025of Commissioner of Police, Kolkata that movement of all types of goods vehicles will be restricted to enter into the Kolkata Police area & Howrah Police Commissionerate jurisdiction from 05.30 hrs to 12.00 hrs on those days. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police Howrah do hereby issue the following restriction orders as per the following time-schedules on the following roads -

Restrictions for Goods Vehicles:

Movement of all types of Goods vehicles will be restricted from 05.30 hrs to 12.00 hrs on 03.03.2025, 04.03.2025, 05.03.2025, 06.03.2025, 07.03.2025, 08.03.2025, 10.03.2025, 11.03.2025, 13.03.2025, 17.03.2025 and 18.03.2025 in following roads-

- 1. All kinds of Goods Vehicles will be restricted at No entry point at Alampur under flyover towards Andul Road 2nd Hooghly Bridge.
- Kazipara Crossing towards Kolkata via 2nd Hooghly Bridge. 2.

- Hang-Sung Crossing towards Sailen Manna Sarani (Drainage Canal 3. Road)& 2nd Hooghly Bridge.
- At Nibra-2 point from NH-16. 4.
- Near Nibra More towards Kolkata & Howrah City along Kona 5. Expressway & 2nd Hooghly Bridge. Ramp of 2nd Hooghly Bridge towards Mandirtala.
- 6.
- T.C. Motor near Salap More towards Kolkata via 2nd Hooahly 7. Bridge.
- 8. NH-19& NH-16 crossing towards Nibedita Setu.
- 'O' point towards Old Bally Bridge / Nibedita Setu. 9.
- Nimtala crossing towards Bally along GT Road. 10
- 11. Ballykhal Island towards Bally along GT Road.
- 12. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally.

Exceptions:

- \triangleright Emergency vehicles like - Vehicles carrying LPG Cylinders only, Petroleum, Oil, Lubricants, Oxygen, Milk, Medicine, Vegetable / Fruits / Fish etc. and CNG carrying Vehicles shall be additionally allowed upto 08:00 hrs on all the above mentioned dates.
- \triangleright Port originated / Port bound Goods vehicles shall be additionally allowed upto 08:00 hrs on all the above mentioned dates.

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.

THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THOSE DAYS, WHICH ARE NOT REPUGNANT TO THE ABOVE.
