WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur and Chatterjeehat Police Station) in the town of Howrah (hereinafter referred to as the said areas).

And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.- 1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023).

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the **6<sup>th</sup> March, 2025 to 4<sup>th</sup> May, 2025** until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

## The Schedule

**The area within the jurisdiction of Shibpur and Chatterjeehat Police Station in the town of Howrah bounded -**

- 1) On the North by - Haradeb Bhattacharyay Road upto and including Mandirtala Bus Stand.

- 2) On the East by - Khetro Banerjee Road, Nabin Banerjee Lane, A K Roy Chowdhury Lane and Mollapara Lane upto G T Road crossing including Kazipara Morh. Hiralal Banerjee Road, Dinu Master Lane, Mollahpara Lane upto G.T. Road Crossing (D.B. College), Danesh Mollah Lane upto G T Road crossing.
- 3) On the West by - K. M. Banerjee Road, Circular 2<sup>nd</sup> Bye Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road upto old 58 Bus stand.
- 4) On the South by - Tarapada Chatterjee Road, Upen Chatterjee Road upto Betaitala Morh.

## All the ramps of Vidyasagar Setu on Howrah side.

- 5) Explanation - In this order, the Town of Howrah means the town of Howrah as defined in Section 2(15) and Schedule - I of the Howrah Municipal Corporation Act, 1980 (Act of 29 of 1980).

Whereas for peaceful completion of one Manhole work of 'KMDA' authority in front of Round Tank LS on the Foreshore Road at Howrah Facility. This office is informed by Executive Engineer, EB-1 GAP-Wing, W&S Sector, KMDA dated 31.12.2024 of reference Memo No 165/EE/GAP(EB-I)/W&S/KMDA/2W-02/2021/24-25 dated 31.12.2024 of KMDA. It is necessary in the interest of Public safety and also to prevent danger, obstruction, and inconvenience to public in general during the work, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate during the period.

I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah in exercise of power conferred upon me u/s 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, Govt. of West Bengal, the following order on the following stretch of road and time as mentioned hereunder,

**Restriction date and time: From 22.00 hrs on 08.03.2025 to 23.00 hrs on 11.03.2025 to until completion of the work.**

## **Restriction and Diversion all types of Vehicles:**

1. Closure of Kartick Chandra Dutta Road from Burn Standard More to Ramkrishnapur Ghat crossing on Foreshore Road under Howrah Police Station from 22.00 hrs on 08.03.2025 to 23.00 hrs on 11.03.2025.
2. Foreshore Road bound no Buses & Goods Vehicles will be allowed to ply on Kartick Chandra Dutta Road.
3. All Kazipara bound Buses and all type of Goods Vehicles coming from (i) Howrah Railway Station side (ii) Coming from DM Bungalow side (iii) Coming from Howrah Police Station side will be diverted through Burn More - Burn Railway crossing - Rail Museum - Grand Foreshore Road - Banstala Ghat - Foreshore Road.
4. All Kazipara bound Long distance Buses will avail Howrah Bridge approach - Howrah Railway Station- Grand Foreshore Road - Banstala Ghat - Foreshore Road.
5. No Goods Vehicles coming from Bally and Golabari side will be allowed towards R B Setu / CM Bridge. They will be diverted through Banaras Road or through Bally - Nimtala - GT Road towards highway.
6. All type of small Vehicles viz. Four wheelers, Three Wheelers, Two Wheelers, coming from Foreshore Road towards Burn more will be diverted from Ramkrishnapur Ghat crossing then Left Turn - Bon Behari Bose Road -Right turn -R T Lane then Burn More.
7. All type of Goods Vehicles (Howrah bound) who intend to avail Foreshore Road, will be diverted through Ramkrishnapur Ghat crossing- Grand Foreshore Road - Rail Museum - Burn More.
8. All route Buses those are originating from Howrah Bus Stand and Mini Bus Route No-6 & 8 will be diverted through R B Setu - D M Slope - Burn More - Rail Museum - Grand Foreshore Road - Foreshore Road.
9. All route Buses originating from Kolkata side (Except route No-6 & 8 mini bus) will be diverted from Howrah Bridge - Howrah Railway Station - Howrah Rail Museum- Grand Foreshore Road - Foreshore Road.

➤ **These regulations will remain in force in addition to the other normal traffic restrictions on those days, which are not repugnant to the above.**

➤ *Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.*

*Vehicles may also be diverted at day time from any of the above roads if deemed necessary*
