Memo No. 343 (60)/CP, HPC

Whereas for peaceful observance of Ram Nabami Puja and Procession of Ram Nabami festival to be celebrated on 06.04.2025 (Sunday) throughout the Howrah Town area, it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to Public in general during the Procession, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Police

Commissionerate & Kolkata Police Jurisdiction during the period. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules on the following roads.

Restrictions for Goods Vehicles:

Movement of all types of Goods Vehicles (except Emergency vehicles likevehicles carrying LPG cylinders only, CNG, petroleum, oil, lubricants, oxygen, milk, medicine, vegetable, fish, fruits etc.) restricted to enter into Kolkata bound from 11:30 hrs to 00:00 hrs on 06.04.2025.

- All kinds of goods vehicles will be restricted at No entry point at Alampur under flyover towards Andul Road 2nd Hooghly Bridge.
- Kazipara crossing towards Kolkata via 2nd Hooghly Bridge. Kazipara Crossing towards Andul Road / 2nd Hooghly Bridge.
- Kazipara Crossing towards Howrah Maidan along G.T. Road.
- Hang-Sung crossing towards Sailen Manna Sarani (Drainage Canal) Road & 2nd Hooghly Bridge.
- At Nibra-2 point from NH-16.
- Near Nibra More towards Kolkata & Howrah City Kona Expressway & 2nd Hooghly Bridge.
- Ramp of 2nd Hooghly Bridge towards Mandirtala.
- T.C. Motor near Salap More towards Kolkata via 2nd Hooghly
- 10. Kona Truck Terminal towards Howrah City along Kona Express Way & 2nd Hooghly Bridge.
- 11. Nibra High School towards Kona Express way& 2nd Hooghly Bridge.
- 12. NH-19& NH-16 crossing towards Nibedita Setu.
- 13. 'O' point towards Old Bally Bridge / Nibedita Setu.
- 14. Nimtala crossing towards Bally along G.T. Road.
- 15. Ballykhal Island towards Bally along G.T. Road.
- 16. Maitypara crossing towards Gurudwara / Nibedita Setu / Bally.

Restrictions / Diversion for All types of Vehicles:

Movement of all types of vehicles & Auto / TOTO (except Emergency vehicles like- vehicles carrying LPG cylinders only, CNG, petroleum, oil, lubricants, oxygen, milk, medicine, vegetable, fish, fruits etc.) will be restricted on 06.04.2025from 07:00 hrs to till completion of the procession on the following roads:

- 1) Kazipara bound all types of vehicles will be diverted from Bataitala Ramp towards Narkeltala via Ramp, sharp bend to Kazipara crossing.
- Kazipara towards Bataitala all types of vehicles will be diverted through Bharpara-Andul Road.
- Coal Depot towards Bataitala all types of vehicles will be diverted through Duke Road.
- For the time being Kazipara to Coal Depot on JB Ghat Road will remain closed and Coal Depot to Kazipara will run both way.
- Kazipara to Howrah Maidan on G T Road all vehicles will be diverted through Foreshore Road depending on Rally location.

- 6) All Vehicles will be diverted from Railway Museum towards Burn More and Foreshore Road depending on location of Rally at Ramkrishnapur Ghat.
- Vehicles restriction will be at Panchanantala Road and Phanshitala depending on location of Rally.
- 8) No entry point from Hanskhali Pole on Andul Road.
- No entry point on Matwala crossing.
- All kinds of Goods Vehicles restricted from Salap Bazar on Howrah— Amta Road.
- All kinds of Goods Vehicles restricted from Abada on Sankrail Station Road.
- 12) All *kinds*of Goods Vehicles *restricted* from N.C. Pal Bridge towards Nazirganj on Satyandra Nath Basu Road.
- 13) Diversion from Panchanantala More.
- 14) No entry point from 52 No Old Bus Stand towards Ramrajatala.
- 15) Diversion from Santragachi More.
- 16) No entry point from Kalpana Clinic towards Ramrajatala.
- 17) Diversion from Indira Gandhi Statue.
- 18) Diversion from Natun Rasta crossing.
- 19) Diversion from Dalalpukur.
- 20) All *kinds* of Goods Vehicles *restricted* from Kona More towards Jagadishpur Bound.
- 21) Kona Morh on NH-16 towards Liluah along Benaras Road.
- 22) Diversion from CTI Morh.
- 23) Diversion from Belgachia Morh on Beneras Road.
- 24) Diversion from 'A' Road crossing.
- 25) All kinds of Goods Vehicles restriction/diversion on NS Road approaching towards Liluah Flyover from Liluah side &Bally side.
- 26) All kinds of Goods Vehicles restriction/diversion on Bamungachi Bridge.
- 27) From CM Bridge to Salkia Chowrasta on G.T Road.
- 28) On Dobson Road.
- 29) On Dr. Abani Dutta Road.
- 30) On Kshetra Mitra Lane.
- 31) Diversion Point C.M. Bridge all Pilkhana bound vehicles restricted from C.M. Bridge and diverted towards Harimohan Bose Road and Dobson Road and HIT Bridge.(As and when restricted)
- 32) Harimohan Bose and G.R. Road crossing all Ghasbagan bound vehicles diverted towards 27A point and HIT Bridge. (As and when restricted)
- 33) G.R. Road and Mukhram Kanoria Road No vehicles allowed towards Dobson Road and I.C. Bose road. (As and when restricted)
- 34) G.R.Road & I.C. Bose Road crossing near Howrah Bus Stand:- All sorts of vehicles are diverted towards R.B. Setu Old Cab Road(right turn) 27A point –HIT Bridge. (As and when restricted)

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.

THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THE DAY, WHICH ARE NOT REPUGNANT TO THE ABOVE.
