WHEREAS, there is every apprehension of breach of peace and tranquility on the day of examination in the vicinity of examination centres,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of the above mentioned examination centres within the Metropolitan area of Howrah on 27.04.25 from 07:00 hrs. to 17:00 hrs. on the day of Joint Entrance Examination (WBJEE-2025), as mentioned above.

And all the **Photo Cyber Café/Photo Copy/Printing Shops** operating within **100 meters** from the above examination centres shall not be allowed to operate <u>on **27.04.25** from **07:00** hrs. to **17:00** hrs. during the hours of examination mentioned above on the aforesaid day.</u>

And any loud speaker/Public address system shall not be allowed to play on 27.04.25 from 07:00 hrs. to 17:00 hrs. during the hours of examination mentioned above on the aforesaid day.

Whereas for preventing danger, obstruction or inconvenience to the public in connection with Inauguration programme of Jagannath Dham at Digha Dist.- Purba Medinipur on 30.04.2025, it is necessary in the interest of Public safety, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate area. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue following restriction order as per following time schedule on the following roads --

Date & Time -

From 06:00 hrs. to 23:00 hrs. on 30.04.2025.

<u>Restrictions for all type of Goods Vehicles</u> (except emergency vehicles, LPG vehicles, Vegetable, Fruits, Medicine & Milk carrying vehicles) at following points-

- . Maitypara from Dankuni side towards Kharagpur bound on NH-16.
- 2. From Nibedita Toll towards Kharagpur bound on NH-16.
- Kona Morh towards Kharagpur bound on NH-16 and towards Bardhaman, Dakhinswar bound.
- No goods vehicle originating from Sankrail Station Road area will move towards kolaghat through NH16 and towards Kolkata & Bardhaman bound.
- No goods vehicle from Dhulagarh Truck Terminal, Sankrail Industrial Park and Dhulagarh Food Park will move towards Kolaghat through NH16 and towards Kolkata & Bardhaman bound.
- No goods vehicle from Ranihati Amta Road will move towards Kolaghat through NH16 and towards Kolkata & Bardhaman bound.
- No goods vehicle originating from Jalan 1 complex, Jalan 3 complex, any parking lot, weigh bridge and any other complexes will move towards kolaghat through NH16 and towards Kolkata & Bardhaman bound.
- No goods vehicle will move towards Kolaghat through NH16 from Saraswati complex and Saraswati Bridge side and towards Kolkata & Bardhaman bound.
- 9. No goods vehicle from Howrah Amta Road will move towards Kolaghat through NH16 and towards Kolkata & Bardhaman bound.
- 10. Salap towards Khargpur bound on NH-16.
- 11. Alampur Morh towards Kharagpur bound on NH-16 and towards Kolkata, Bardhaman and Dakhinswar bound.
- 12. 2nd HB towards Nibra bound on Kona Express way and Andul Road.
- 13. Hung Sung crossing towards Nibra bound on Kona Express way.
- 14. Nibra crossing towards Kolkata and Bardhaman / Dakhinswar bound / Kharagpur bound on NH-16.
- 15. Kona Truck Terminal towards Kolkata and Nibra bound on NH-16.

In addition to the above, no Goods Vehicles will be allowed to ply within this Commissionerate area from 06:00 hrs. to 23:00 hrs. on 30.04.2025.

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.

These regulations will remain in force in addition to the other normal traffic restrictions on that day, which are not repugnant to the above.
