WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur and Chatterjeehat Police Station) in the town of Howrah (hereinafter referred to as the said areas).

And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.- 1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023).

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the 5<sup>th</sup> May, 2025 to 3<sup>rd</sup> July, 2025 until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

#### The Schedule

The area within the jurisdiction of Shibpur and Chatterjeehat Police Station in the town of Howrah bounded -

- 1) On the North by Haradeb Bhattacharyay Road upto and including Mandirtala Bus Stand.
- 2) On the East by Khetro Banerjee Road, Nabin Banerjee Lane, A K Roy Chowdhury Lane and Mollapara Lane upto G T Road crossing including Kazipara Morh. Hiralal Banerjee Road, Dinu Master Lane, Mollahpara Lane upto G.T. Road Crossing (D.B. College), Danesh Mollah Lane upto G T Road crossing.
- 3) On the West by K. M. Banerjee Road, Circular 2<sup>nd</sup> Bye Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road upto old 58 Bus stand.
- On the South by Tarapada Chatterjee Road, Upen Chatterjee Road upto Betaitala Morh.

#### All the ramps of Vidyasagar Setu on Howrah side.

5) Explanation - In this order, the Town of Howrah means the town of Howrah as defined in Section 2(15) and Schedule - I of the Howrah Municipal Corporation Act, 1980 (Act of 29 of 1980).

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) do hereby prohibit the assembly of five (5) or more persons within the radius of 100

(hundred) meters of the periphery of the above mentioned examination centres within the Metropolitan area of Howrah on and from 15.05.25 to 03.06.25 as per schedule from 06:00 hrs. to 19:00 hrs. on the days of Common University Entrance Test [CUET] (UG)-2025 Examination (Computer Based Test) as mentioned above.

And all the **Photo Cyber Café/Photo Copy/Printing Shops** operating within **200 to 300 meters** from the above examination centres shall not be allowed to operate on and from 15.05.25 to 03.06.25 as per schedule from 06:00 hrs. to 19:00 hrs. during the hours of examination mentioned above.

And any loud speaker/Public address system shall not be allowed to play on and from 15.05.25 to 03.06.25 as per schedule from 06:00 hrs. to 19:00 hrs. during the hours of examination mentioned above.
