WHEREAS, there is every apprehension of breach of peace and tranquility on the day of examination in the vicinity of examination centres,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub-Section (1) of section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No. -1544-P.S. Cell/HR/O/3P-29/2011 Dated 16.08.2024 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023) do hereby prohibit the assembly of five (5) or more persons within the radius of 100 (hundred) meters of the periphery of the mentioned examination centres within the Metropolitan area of Howrah **from 08:00 hrs. to 14:00 hrs. on the day of Preliminary Examination for Recruitment to the Post of Sub-**

Inspector (Unarmed & Armed Branch) in West Bengal Police – 2024 on 12.10.2025, as mentioned above.

And all the **Photo Cyber Café/Photo Copy/Printing Shops** operating within **100 meters** from the above examination centres shall not be allowed to operate **from 08:00 hrs. to 14:00 hrs. on the day of Preliminary Examination for Recruitment to the Post of Sub-Inspector (Unarmed & Armed Branch) in West Bengal Police – 2024 on 12.10.2025, as mentioned above.**

And any **loud speaker/Public address system** shall not be allowed to play during the hours of examination **from 08:00 hrs. to 14:00 hrs. on the day of Preliminary Examination for Recruitment to the Post of Sub-Inspector (Unarmed & Armed Branch) in West Bengal Police – 2024 on 12.10.2025, as mentioned above.**

Whereas it is necessary in the interest of public safety and convenience for repair & rehabilitation of 2nd Hooghly Bridge (Vidyasagar Setu), including replacement of stay and holding down cables and bearing etc. the work taken up by the HRBC Authority. It is informed by HRBC Authority vide No. HRBC/CPM/Repair V. Setu/091025-2 dated 09.10.2025. Movement of all types of Vehicles shall be restricted through 2nd Hooghly Bridge (Vidyasagar Setu) **from 04:00 hrs. to 09:30 hrs. on 11.10.2025 and again from 14:00 hrs. to 20:30 hrs. on 12.10.2025.** In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders on the following roads -

Restriction Date & Time: from 04:00 hrs. to 09:30 hrs. on 11.10.2025 and again from 14:00 hrs. to 20:30 hrs. on 12.10.2025.

Restrictions / Diversion Point:

1. All types of vehicles will be restricted towards Vidyasagar Setu.
2. No Goods Vehicles will be allowed from Nibra towards Kona Expressway / Vidyasagar Setu.

3. No Goods Vehicles will be allowed from Kona Truck Terminal towards Kona Expressway / Vidyasagar Setu.
4. No Goods Vehicles will be allowed from Alampur Morh towards Vidyasagar Setu through Andul Road.
5. No Goods Vehicles will be allowed from Salap Morh towards Bankra/ Dasnagar through Howrah-Amta Road.
6. No Goods Vehicles will be allowed from Chatterjeepara towards Hang Sang Crossing.
7. No Goods Vehicles will be allowed from Shanpur Morh towards Hang Sang Crossing.
8. No Goods Vehicles will be allowed from Kona Morhtowards Liluah on Benaras Road.
9. No Goods Vehicles will be allowed from Belgachia towards Salkia or East- West Bye pass Road.
10. No Goods Vehicles will be allowed from Hang-sang crossing towards Vidyasagar Setu.
11. No Goods Vehicles will be allowed from Kazipara towards Kolkata through 2nd Hooghly Bridge.
12. All Vehicles other than Goods Vehicles intending to go towards Kolkata by availing Vidyasagar Setu will be diverted through Howrah Bridge (Rabindra Setu) / Nibedita Setu/ Old Bally Bridge (Vivekananda Setu).
13. Kolkata bound vehicles from Kolaghat side may avail Nivedita Setu through the route- Dhulagarh Toll Plaza – Ankurhati – Salap – Pakuria – CCR Bridge – NiveditaSet u or Old Bally Bridge (Vivekananda Setu).
14. Kolkata bound vehicles (except two wheelers) coming from Dankuni can take the route- Maitypara – Nivedita Setu. or Old Bally Bridge (Vivekananda Setu).
15. All vehicles (other than goods vehicles) from Howrah going towards Kolkata can avail Howrah Bridge (Rabindra Setu).

1. *All types of vehicles diversion point Bataitala Ramp / Narkeltala.*
2. *All types of vehicles diversion point Betaitala crossing.*
3. *All types of vehicles diversion point Sharp band point on Howrah Bound Ramp.*
4. *All types of vehicles diversion point Sharashibala School crossing.*
5. *All types of vehicles diversion point Mandirtala.*
6. *All types of vehicles diversion point Exit Ramp towards Toll plaza.*
7. *All types of vehicles diversion point Kazipara crossing.*
8. *Diversion point 27-A point.*
9. *Diversion point Rail Museum.*
10. *Diversion point Belepole crossing.*
11. *Diversion point Hangsang crossing.*
12. *Diversion point Chatterjeepara crossing.*
13. *Diversion point NatunrastaMorh.*
14. *Diversion point Phansitala.*

Vehicles may also be diverted from any of the roads by the Traffic Police on duty as and when considered necessary.
